



# BRIXTON PARISH COUNCIL SPORTS AND RECREATION PLAN

# Background.

Brixton Parish has a number of sports and recreation facilities, but there are significant gaps in provision and there is scope for the improvement of existing facilities. In order to make best use of available and potential funding, particularly section 106 funding from the Venn Farm/Canes Orchard housing development, there is a requirement to review current provision, assess outstanding needs and provide justification and a plan for future developments.

The long term vision of the Parish Council is to create sustainable sports and recreation opportunities that are both formal and informal for all of the community. Opportunities and facilities will be affordable and accessible and will offer educational benefit. This is the Brixton Parish Sports and Recreation Plan.

The plan covers a 10 year period from 1 April 2019 to 31 March 2029.

#### Aim

To expand the provision of sport and recreation facilities in Brixton Parish to meet the requirements of a growing community.

# **Organisations Involved**

**Brixton Parish Council (BPC).** Consists of 9 elected members, supported by the Parish Clerk. The Chair has lead responsibility for the Brixton Parish Sports and Recreation Plan.

**Brixton Community Association (BCA).** Umbrella organisation for a number of village clubs. Responsible for the administration of the Brixton Community Hall (BCH) including those existing community facilities shared with Brixton St Mary's Primary School.

**Brixton St Mary's Primary School (BStM'sPS).** Part of United Schools Federation. It has a large grass sports field, a hard asphalt outdoor sports pitch, outside table tennis tables and a sports hall, all of which are available to the community outside of school hours. The sports hall is bookable by prior arrangement (see below).

#### **Other Interested Organisations**

South Hams District Council Plymouth

Active Devon. Supports specific activities through its Active Villages and Devon Active Communities programmes.

Devon County Council.

## **Population Profile**

Sport England Market Segmentation for the PL8 postcode area (the closest demarcation to the Parish) shows that a large percentage of the Parish population is likely to be actively involved in a range of sports and activities and will therefore respond positively to improved facilities.

The Venn Farm and other housing developments since 2014 have, or will shortly have, increased the village by 25%. A significant proportion of new residents, including young families, would benefit from an increased range of local sport and recreation facilities.

Table 1 below lists the facilities required to meet the current expressed under-provision identified during the Neighbourhood Plan consultation.


#### Current S106 funds available

#### Consultation/Demand identification

This plan is based on the demand expressed during community consultation carried out during the preparation of Brixton Parish Neighbourhood Plan. A summary of response to the parish questionnaire of 2016 is at Fig 1.

**Question 5.2** asked which outdoor activities respondents wished to take part in if the facilities were available or improved.

In addition, Annex 2 of the Questionnaire responses report included comments with specific suggestions for each of the activities proposed in the table of projects below.

#### **Current Facilities**

**Sports grounds**. Grassed playing fields with Rugby pitches at the western edge of the parish, owned by Plymstock Albion Oaks Rugby Club (PAORC). Includes a pavilion with changing rooms and central area including bar and café all recently rebuilt and refurbished with money secured from Sport England and the RFU. Exercise and dance classes at Albion Oakes Club House. Trim Trail at Horsham Playing Fields.

## **Staddiscombe Playing Fields**

Rugby and Football pitches maintained by Plymouth City Council and used by Plymouth soccer teams and Plymouth University.

**Soccer Pitch** in Brixton village, formally part of the Kitley Estate and used by their agreement by SB Frankfort Football club from Plymouth. Not currently available for Brixton teams. The changing facilities are in very poor condition but due to be replaced by a modest combined-use building to be shared with the Scouts and Cubs, re-located from the existing dilapidated building next to the A379. Note below the desire to make this a more substantial multi-use building available to the community.

## **Brixton St Mary's Primary School.**

Grass sports field for athletics football, etc., and a small outdoor hard sports facilities surface for soccer, and potentially for basketball practice. The school-owned facilities are available out of school hours for use by the community. The school is interested in expanding the all-weather play surface for multi-sport use.

There is a small swimming pool at the school that is not currently available for public use outside of school hours, due to lack of adequate lifeguard arrangements.

# Sports/Community Hall at Brixton St Mary's School

The school hall is also used by local groups, out of school hours, for badminton, short mat bowls, yoga, table tennis, gymnastics and dance, all on a regular basis. Hired out by the Brixton Community Association.

#### Community Room.

A room at the school is available for meetings and community indoor activities, hired out by the Brixton Community Association.

#### **Venn Court Sheltered Housing.**

Gentle exercise for improving balance, flexibility and preventing falls.

#### Greenways, footpaths, cycle paths, bridleways.

The parish has a network of public rights of way, which are currently well maintained and well used managed by BPC under the P3 Scheme with Devon County Council. Part of the Erme-Plym Trail runs through the Parish. There is a shared permissive footpath, Silverbridge Way, linking Brixton with Yealmpton through the fields adjacent to the A379. A footpath cycleway from Otter Garden Centre links the village to Elburton via Dawes Lane, however the surface within Plymouth City boundary is in poor condition and in

need of improvement. There is potential to add to these, including opening up neglected rights of way as described below. There are also plans, described in the Neighbourhood Plan for new public rights of way, which are listed in Table 1 under Access to Outdoor Spaces.

Cycleways are limited and there are currently no bridleways within the Parish. Access to the Sherford Country Park is proposed in the Brixton Parish Neighbourhood Plan for pedestrian, cycle and equestrian access.

## **Accessible Natural Green Spaces**

Small grassed area at the head of Cofflete Creek.

# Children's Play Spaces

Good quality children's play spaces are available at Elliots Hill and at Woodland Drive. A Play Trail links the play spaces and open spaces in the village. Small space for under 5's in Canes Orchard. The Feoffee Park provides informal play space.

# **Allotments**

29 allotments at Stamps Hill
