Local Government Reorganisation

In December 2024, Government set out its intention that all areas with two levels of local government (District and County Councils) were required to develop plans for a single level of Government.

Proposals need to be submitted to central government by Friday 28
November. Government will then look at all of the proposals it's received from authorities in Devon and decide which proposal(s) will go to statutory stakeholders for consultation during the first half of 2026. It's expected to make a final decision next summer.

Once Government has backed proposals, shadow elections would be held in May 2027 before the new authority takes on its new powers and responsibilities on 1 April 2028.

South Hams District Council (SHDC's) preferred option for the future, known as the 1-4-5 plan, proposes:

- · Retaining Plymouth unitary authority on its existing boundary.
- · A unitary authority combining the South Hams, Teignbridge and West Devon areas with Torbay.
- · A unitary authority including East, Mid, North Devon, Torridge and Exeter.

Plymouth City Council's (PCC) proposal developed in collaboration with Exeter and Torbay, proposes the replacement of the existing two-tier system with four unitary councils:

- An Expanded Plymouth City Council
 An Expanded Exeter City Council
- An Expanded Exerter City Council
 An Expanded Torbay Council
- A new Devon Coast and Countryside Authority (covering the remaining area)

Devon County Council (DCC) is proposing that Devon County Council and the existing eight district councils are replaced with a single unitary authority, while retaining the existing authorities of Plymouth City Council and Torbay Council.

Highways

BPC Traffic Management Working Group continues to meet remotely with DCC Highways Officer on a quarterly basis and the next meeting will be held in January. Following the two public consultation events regarding Red Lion Hill / Stamps Hill and The Green in May the Clerk collated the feedback into one document. A working group comprising of Clerk, Cllrs Hitchins, Carson and Wills, Community Road Warden, and parishioner met with Richard Jackson, DCC Principal Highways Development Management Officer and Nick Colton DCC Local Highways Officer to discuss the feedback.

Red Lion Hill / Stamps Hill

Following the feedback obtained, the indicative plan has been amended to include 'round profile humps' instead of 'build outs.' Richard Jackson has confirmed that this scheme will be designed by 'EDG and there are no planning related time constraints.

BPC await the final design, there will then be a DCC consultation.

The Green

Feedback in general stated the proposed changes were too complicated and that there was too much change. The suggestion to use the land in Old Road owned by The Brixton Feoffee Trust for car parking was also raised in feedback from parishioners. BPC has contacted Clerk to The Feoffee Trust, and this will be raised at the next meeting of the trustees.

Following this feedback Nick Colton has produced a new indicative map with purely 'no parking restrictions' (double yellow lines) marked in a couple of places on The Green as well as along part of A379. This was approved at the November BPC meeting and DCC Highways Officer has added this plan to the Traffic Regulation Order request list. A further consultation will be undertaken by DCC in due course.

Speed Limits within Brixton

BPC is working in conjunction with DCC Cabinet Member for Highways, DCC County Councillor Carson and DCC Local Highways Officer to reduce the speed limits in Brixton, especially Red Lion Hill / Stamps Hill to Sherford. BPC has also asked for a review of the speed limits within the village. BPC has contacted Yealmpton Parish Council (YPC) regarding a reduction in speed along A379 between Brixton and Yealmpton, YPC will be consulting the community.

Monkey Lane

DCC has issued a Traffic Regulation Order (TRO) for Monkey Lane to be downgraded to a multi- use lane (Pedestrians, Cyclists and Horse Riders) with a prohibition of vehicles except for access. The signs prohibiting vehicles except for access are now in situ at both ends of Monkey Lane with bollards also now installed.

It has also been confirmed that there will be a path, running alongside the hedge into the Sherford Country Park from the Sherford end of Monkey Lane, this will join with PROW 18 to West Sherford.

Climate Change

River Yealm Water Quality Group

This working group with the 7 Riparian Parish Councils in the River Yealm Catchment area together with other interested parties continues to meet to work with Environment Agency and South West Water to monitor the quality of water in the River Yealm particularly relating to the discharge of sewage into the river at times of heavy rainfall. BPC owns the parcel of land at the head of Cofflete Creek on the site of the former Cofflete Mill. Following consultation with parishioners, the aim is to create a community amenity space for the residents of Brixton Parish, through careful consideration of the significant historic and environmental value of this piece of land to the community. - Entrance to Chittleburn Business Park
